To accommodate various budgetary constraints, the total investment for the full-service package can be conveniently divided into monthly installments. A 25% deposit of the first month's payment is required upon contract execution to secure services and begin the planning process. This flexible payment structure ensures clients have access to premium event planning services while maintaining financial comfort. Additional enhancements or services can be incorporated at any stage, making this package an adaptable solution for any event size or complexity.

The total investment can be divided into monthly payments, allowing flexibility and ease of payment. A 25% deposit of the first month's payment is due upon contract execution to secure services. DJ's EP brings all the expertise and knowledge of a traditional planner, but my process allows you to keep your personal stamp on your event because you are the ultimate decision maker!

What if I book a package and decide I want to downgrade or upgrade my level of support?

I recognize that events can unfold rapidly in the planning industry. Consequently, we permit a package upgrade or downgrade by one level within the first 14 days, provided that we have only delivered the services associated with the lower-tier package. These services encompass referrals, information, guidance, and support.

Can I pay the fees in installments?

Due to the intricacies of the event planning process, a 25% deposit of the total fee is required at the time of contract execution to initiate services. For events scheduled six months or more in advance with DJ's EP, I offer the option to divide the remaining fee into monthly installments. In this case, the initial 25% deposit is due upon signing the contract, with the balance payable by the end of the month.

What are your available hours for consultation, and what format do these consultations take?

All packaged consultations are arranged online. Most consultations are scheduled from Monday to Friday, with Saturday appointments available upon request. Consultations can be conducted via Zoom, Google Meet, phone call, or in person for local clients.
